SUMMER 2008 COURSE ANNOUNCEMENT**

Course:

A 136 hour training program offered in an intensive format for the recertification of persons who have previously completed a P.O.S.T. certified Basic Academy and who have had a three year or longer break in service as a regular Peace Officer in another state and have completed the waiver processes and received a valid Basic Course Waiver (B.C.W) letter from P.O.S.T. **Six year exception:** An individual who successfully completed a Regular Basic Course, Specialized Investigators' Basic Course or the Basic Waiver Process **on or after July 1, 1999 but who never served** in a California peace officer/Level I reserve officer position for which a Regular of Specialized Investigators' Basic Course is required, may re-qualify by successfully completing a P.O.S.T- certified Re-qualification Course on time within six years from the date of basic course or waiver process completion. After six years, an individual must successfully complete the appropriate basic course (RBC or SIBC) to re-qualify, regardless of when the re-qualification Course was completed. If you are not sure of your status with P.O.S.T. please contact them prior to enrolling.

*****All pre-requisites are due on April 29, 2008 including the \$40 Material/Duplication Fees.*****Your slot is not confirmed until all documents are turned in, if we do not receive your documents by the date above your slot will be given to another candidate.

Pre-Requisites:

- **D.O.J. Finger print clearance (no felony convictions)** - fingerprints need to be done at an agency with live scan capability (cost is involved). A copy of the completed form will secure your spot; however, you must be cleared prior to going to the range. A letter from a sponsoring agency stating clearance through the employment process will also be sufficient.
- **Proof of completion of Basic Academy** - copy of certificate or POST printout.
- **Physician's Release** -Please use the clearance form that applies to you (affiliated/non-affiliated). The Health History statement & Par Q must also be completed and submitted with physician's release.
- **Check or money order** - \$40 fee payable to Yuba College (Material/Duplicating fees as listed on next page). This fee is refundable up until two weeks before the course start date. If we are not given a two-week cancellation notice this fee will not be refundable.
- **Register as a college student thru the Yuba website at www.yccd.edu.** Please email cgil@yccd.edu once this is accomplished to finalize your enrollment. **If you are an out of state resident, please contact our office immediately.**
- **Parking Decals** – Daily passes are available through the Registration Office, the Police Department or during orientation. We do request that the Police Department suspend citations until we make sure all students have their decals on first day of class. Cashier should be available at 7:30 a.m. on first day. Please call to confirm if you need assistance obtaining your daily passes.

Please contact our department prior to submitting payment. Invoicing for fees is available. Please submit a letter with your pre-requisites stating who is to receive the invoice/billing.

Range

Firearm (semi-automatic, reputable manufacturer)
3 Magazines / 1 Magazine holder (must hold 2 magazines)

Ammunition required:

- **600 rounds of “handgun ammo”**
(more may be needed if you are an inexperienced shooter)
- **50 rounds of 2 ¾ “bird shot”**
(any thing between 7 ½ - 9 shot is acceptable) Big box stores i.e. Wal-Mart has 100 round packs for around \$17, you can partner up with someone else and split the cost.
- **25 rounds of 2 ¾ “00” buck shot.** 9 pellets only, no 12-15 pellets will be allowed. “00” usually comes in packs of (5) shells.
- **25 rounds of 2 ¾ “lead slugs”.** They must be one-ounce lead slugs. NO sabot rounds are allowed.

You may purchase your ammunition before or after the course begins. There are nearby stores to purchase your ammunition. A range master will be there the first few days of class to answer all of your questions prior to actual range days. Dress appropriately for any weather. Hats are recommended to keep the sun and ejected brass off your face and head. You should bring and wear sunscreen and drink plenty of water. It may rain, so students need to bring the appropriate gear and be prepared to shoot in any weather.

I. Pre-Requisites

NOTE: Department of Justice fingerprint clearance for firearms is required prior to attending the firearms portion of this Academy. Agency affiliates may provide a letter from their respective employer that states that they have already received firearms clearance as part of the screening process for employment. The date of this clearance should be included also. It generally takes 20-25 days to get a fingerprint clearance back from D.O.J., so it is imperative that students submit prints well before the start of the Academy.

II. Attendance

90% attendance for the entire course

100% attendance for critical subjects. Critical subjects are defined as follows:

1. Firearms Training
2. Arrest Methods
3. Scenarios

Agency affiliated students are responsible for notification to their respective agencies in the event of any amount of time missed during this course. Additionally, the Facilitator must receive a memo from the student in order to account for any time missed in this course.

III. Grading

A. Written examinations

- (1) Throughout the length of the Academy when a cadet fails the POST constructed exam, he/she will be allowed to successfully remediate that exam. A total of one (1) successful remediation will be allowed.
- (2) To assist the cadet in passing the remediation examination, remediation instruction and remediation assignments will be offered. It will be the cadet's choice whether or not to accept these assignments.

B. Firearms

- (1) All students will bring their own handguns, none will be provided, and will have to pass (qualify) with their handguns and shotgun in various firearms courses set by the Course Range Masters and based on POST training

- specifications.
- (2) 90% of the total points possible are needed by each cadet to pass each of the qualifying courses. Failure to attain a 90% score, after remediation, will result in dismissal from the course.

C. **Arrest Methods (Person searches, handcuffing, baton, etc.)**

- (1) Cadets will be expected to demonstrate learned skills in these areas.
- (2) Scoring is a pass-fail method. Failure of an initial demonstration and a remediation demonstration will result in dismissal from the Course.

IV. Dress Code

This section applies to both **Male and Female** students.

Classroom/Lecture: Slacks, Polo shirts. No shorts. Blue jeans or black BDU pants may be worn for firearms training.

Gym Clothing:

Each student is required to have a prescribed set of gym clothing **before the first Firearms or Arrest Methods session begins.**

This includes:

1. A minimum of one white t-shirt.
2. One pair of blue, black or gray sweat pants.
3. One pair of blue, black or gray gym shorts.
4. White Athletic Shoes

Arrest Methods:

White T-Shirt, shorts and sweatpants. Males-athletic supporter (recommended). Females-Athletic bra (recommended). White Athletic shoes, duty belt and gear.

Firearms Training:

Blue jeans or black BDU pants, white t-shirt, tennis shoes, duty belt and gear, and/or baseball hat as required by Range master.

Equipment:

Duty belt (leather or nylon), holster, magazine holder (holds a minimum of two magazines), belt keepers, handcuff case, handcuffs and key.

Firearms: must be semi-automatic, 9mm, .45, .40 caliber only from a reputable manufacturer and in good working order. Firearm must be double action (no single action). A minimum of three magazines is required. Students

must provide their own firearm/magazines. Arrangements must be made in advance to borrow academy weapons and they are on a first come/first served basis. Students will be required to provide their own gun cleaning kit.

Protective Vests: Affiliated students must bring their own body armor unless arrangements have been made with Academy Staff to loan a protective vest. Students who are non-affiliated may arrange to have a vest provided by Range Staff.

Range Eye/Ear Protection: Eye protective glasses are available. We strongly suggest you provide your own. Ear protective covers are provided.

Ammunition: 600 rounds “handgun”
50 rounds 2 ¾ “bird shot”
25 rounds 2 ¾ “00” buck shot
25 rounds 2 ¾ “lead slugs”

V. GROOMING STANDARDS

I. UNIFORM AND GROOMING STANDARDS

A. DRESS CODE:

This section applies to both Male and Female students.

Classroom/Lecture: Slacks, Dockers or better (tan or brown), polo shirts. No shorts

Gym Clothes: Each student is required to have a prescribed set of gym clothes.
Before the first Firearms or Arrest Methods session begins.

This includes:

1. A minimum of one plain white “T” shirt.
2. One pair of blue sweat pants.
3. One pair of blue gym shorts.

Arrest Methods:

White “T” shirt and navy blue sweat pants.

Males-athletic supporter (recommended).

Females-Athletic bra (recommended).

Tennis shoes, duty belt (and gear).

Firearms Training: Blue jeans, white T-shirt, (summer), L/S blue or black sweatshirt, tennis shoes, duty belt (and gear) and/or baseball hat as required by range master.

Equipment: Duty belt (leather or nylon), holster, magazine holder (holds a minimum of two magazines), belt keepers, handcuff case, handcuffs and key.

Firearm: Must be semi-automatic, 9mm, .45, .40 caliber only from a reputable manufacturer and in good working order. Firearm must be double action (no single action). A minimum of three magazines is required. Students must provide their own firearm/magazines. Arrangements must be made in advance to borrow academy weapons and they are on a first come/first served basis.

Protective Vests: Affiliated students must bring their own body armor unless arrangements have been made with Academy Staff to loan a protective vest. Students who are non-affiliated may arrange to have a vest provided by Range Staff.

B. GROOMING STANDARDS

1. Requirements

- a. Students shall be neat and properly groomed at all times while in attendance at the Academy. The following standards will be met prior to the first day of training, and shall be maintained through the day of graduation.

2. Male

- a. Male Students shall be clean-shaven for all classes, inspections and formations.
- b. Beards or mustaches are allowed.
 - (1) Those students not having a mustache or beard when the academy begins will not be allowed to grow one while

attending the academy.

- c. No hairpieces shall be worn.
- d. The following items of jewelry may be worn:
 - (1) “Medical Alert” bracelet.
 - (2) A total of two conservative rings, one of which may be a wedding ring. All jewelry is prohibited in defensive tactics.
- e. Earrings and body piercing jewelry are prohibited during all scheduled training.

3. Female.

- a. Hair extending below the collar shall be worn up “off the collar” during defensive tactics. Hair must be neat and secured during defensive tactics.
- b. No hairpieces will be worn.
- c. No decorations shall be worn in the hair. Hair clips or pins that match the color of the hair may be worn.
- d. False eyelashes are prohibited.
- e. Fingernails shall be trimmed so as not to interfere with the training program. Nail polish may be worn.
- f. Brassieres shall be worn at all times during training and will provide adequate support.
- g. Earrings and body piercing jewelry are prohibited during firearms and defensive tactics.

VI. POLICIES AND PROCEDURES:

General:

Each Student will be provided with a Yuba College Student Basic Re-qualification Rules and Regulations handbook during orientation, which is appropriate and applicable to all students. Additionally, students will be provided a variety of safety policies, acknowledgments, and waivers that must be signed during the orientation session. At all times, affiliated students are subject to the rules and regulations of

their respective agencies. A student must immediately report any injuries to Academy Staff. Furthermore, agency affiliated students must report any injuries sustained during Academy hours to their respective employer as soon as is reasonably possible. This will afford the employer the opportunity to submit Worker's Compensation paperwork within established time frames.

IX PHYSICAL REQUIREMENTS:

This course contains numerous hours of Arrest Control Methods. Students must participate in all aspects of this training unless excused by a physician for an injury or illness. *Students are required to perform a variety of physically demanding activities including; Repetitive bending, standing, rapid/multi-dimensional foot movements, sustained and repeated application of pain compliance techniques to wrist/elbow/shoulder joints, and stretching/warm-up exercises to include push-ups and sit-ups. Students should prepare prior to the commencement of this course.*

NOTE: All students are required to complete a medical clearance/physician's release prior to participating in any of the prescribed physical activities. Affiliated students must present a letter (prior to the first Arrest Methods session) from their respective agency stating that a medical examination was performed as part of the employment screening process and there are no limitations or restrictions that would prohibit the student from participation in this course.
