AGREEMENT FOR SERVICES

THIS AGREEMENT is hereby entered into by the YUBA COMMUNITY COLLEGE FOUNDATION, hereinafter referred to as the FOUNDATION, and:

CONTRACTOR agrees to provide to FOUNDATION the services enumerated in Section "H" of this Agreement under the following terms and conditions -

- A. Services shall begin on _____ and shall be completed on or before _____.
- B. In consideration for services performed by CONTRACTOR, FOUNDATION agrees to pay CONTRACTOR:

_____ Payment(s) shall be made based on invoice(s) submitted to the FOUNDATION by CONTRACTOR and approved by a Foundation Representative.
- C. CONTRACTOR understands and agrees that he/she and all of his/her employees are not employees of the FOUNDATION and are not covered by benefits to which employees are normally entitled, including State Unemployment Insurance or Workers' Compensation. CONTRACTOR shall assume full responsibility for payment of all federal state, and local taxes or contributions including Unemployment Insurance, Social Security, and Income Taxes with respect to CONTRACTOR's employees.
- D. CONTRACTOR shall furnish, at their expense, all labor, materials, equipment, and other items necessary to carry out the terms of this agreement, except for that provided by the District.
- E. In the performance of the work herein contemplated, CONTRACTOR is an independent contractor, with the authority to control and direct the performance of the details of the work, FOUNDATION being interested only in the results obtained.
- F. CONTRACTOR agrees to defend, indemnify and hold harmless the FOUNDATION, its Board of Trustees, employees, and agents from any and all liability of loss arising in any way out of CONTRACTOR's employees or agents.
- G. CONTRACTOR shall provide FOUNDATION WITH A Certificate of Insurance showing a minimum \$ N/A combined single limits of general liability and automobile coverages as required by the FOUNDATION.
- H. Services to be rendered to the DISTRICT by the CONTRACTOR are as follows: _____
- I. Neither party shall assign or delegate any part of this Agreement without the written consent of the other party.
- J. The work completed herein must meet the approval of the district and shall be subject to the DISTRICT's general right of inspection and supervision to secure the satisfactory completion thereof. CONTRACTOR agrees to comply with all Federal, State, Municipal, and District laws, rules, and regulation that are now, or may in the future become applicable to CONTRACTOR, CONTRACTOR's business, equipment, and personnel engaged in operations covered by this Agreement or accruing out of the performance of such operations.
- K. This agreement may be terminated by either party notifying the other, in writing, at least 2 days prior to the date of termination.
