Pursuant to the Notice Inviting Bids, and in compliance with the Instructions to Bidders, having attended the full duration of the mandatory pre-bid meeting, reviewed the Contract documents and the site(s) of the work, the undersigned hereby proposes to furnish all work, labor, tools, materials, transportation, equipment, services and other means of construction necessary for the completion of the project entitled marked "Informal Bid 09-I007-J30 IT Server Room Wire Management", all in accordance with the specifications, District plans, working details and other Contract documents, together with all Addenda issued by the District prior to the opening of the Bids, if any, now on file at the office of the Purchasing Agent, located 2088 North Beale Road, Marysville, California, Building 1300, Room 1309, for the sum of Forty Four Thousand Dollars, (\$ 44,000.00).

12 The undersigned agrees that the enclosed cash deposit, cashier's check, certified check or surety
13 bond accompanying this proposal shall be left on deposit with the District. The undersigned further
14 agrees that this amount is the measure of the liquidated damages which the District will sustain by
15 the default of the undersigned through failure to execute and deliver the above agreement and
16 bonds within ten (10) days of written Notice to Proceed of the Contract to the undersigned and that
17 the money or surety bond so deposited shall be collectible and become the property of the District
18 in case of such default.

19 Within seven (7) days after the bid openings, the responsible low bidder shall deliver, in a form
20 acceptable to the District, a complete cost breakdown for the project herein bid.

21 As required by Public Contract Code section 4101, and stated in the Section 000120 Instructions to
22 Bidders, Section 1.08, listed hereunder is the name of each subcontractor and the address and
23 location of place of business of the mill, shop or office of each subcontractor who will perform work
24 or labor or render service to the undersigned in or about the construction of the work hereinabove
25 described in excess of one-half of one percent (0.5%) of the total bid and the portion of said work
26 which will be done by each subcontractor, if the Contract for the said work is awarded to the
27 undersigned. (Attach additional sheet, if necessary, and note attachment on this page.) (See Pub.
28 Contract Code, §§ 4100-4113.)

29 **As set forth in General Conditions Section 00700, Article 6, the Bidder's own organization**
30 **shall perform Contract work amounting to not less than 20 percent of the original total**
31 **Contract price. In accordance with those provisions, every Bidder also shall set forth in its**
32 **bid the percentage that the value of the work to be performed by each listed subcontractor**
33 **bears to the Bidder's total bid. The failure to comply with this requirement will render the**
34 **bid materially non-responsive. Further, if the listing shows that the Bidder has attributed**
35 **more than 80 percent of the total bid, to subcontractors, the bid shall be deemed materially**
36 **non-responsive.**


