# YCCD Daily Update

Friday, April 3, 2020

Daily Update provides information on the current status of the COVID-19 crisis related to Yuba Community College District, and shares information from both local, state and national media outlets.

### **CURRENT STATUS**

As of this morning there were a total of 56 confirmed cases of COVID-19 in the service area of Yuba Community College District; one in Colusa County, zero in Lake County, 14 in Sutter County, 33 in Yolo County (4 of which are in Woodland) and eight in Yuba County. Statewide there are a total of 9,191 confirmed cases reported as of April 2, 2020 according to the California Department of Public Health.

## CALIFORNIA COLLEGE STUDENT EMERGENCY SUPPORT FUND

During these challenging times, it is more important than ever to help the most vulnerable students stay in school, earn their degrees, and build a better future for themselves and our communities.

The California College Student Emergency Support Fund has launched to give one-time \$500 hardship grants to students. Administered by Mission Asset Fund (MAF), the Fund is a statewide philanthropic response to address emergency needs for the state's low-income college students, including undocumented immigrants, foster youth, and those who are housing insecure.

As colleges and universities respond to the worldwide COVID-19 pandemic, students find themselves facing a wide variety of challenges and costs. The Fund was created to cover unplanned financial expenses such as housing, technology, and more to support educational continuity, persistence, and degree completion for California's college students through this crisis.

Applications and grant payments to students will be processed by MAF. MAF is a well-established non-profit organization that carried out a similar emergency fund effort in 2017 to pay for DACA (Deferred Action for Childhood Arrivals) recipients' renewal fees.

We encourage interested students to apply as quickly as possible as these funds will go fast.

It will help to have the following items at the ready: your transcript, financial aid eligibility (any financial aid statement or award letter that shows EFC or California College Promise Grant Fee Waiver), and electronic banking login information (not required).

#### **TCSIG AND COVID-19 TESTING**

With the passage of Families First Coronavirus Response Act, Federal Guidelines mandate coverage for COVID-19 testing which states that private health plans, fully-insured and self-insured plans, are now required to provide coverage for COVID-19, which include: Diagnostic testing, cost of provider, urgent care center and emergency room visits (in order to receive testing), and any related medical services.

The coverage provided for testing as noted above, must be at no cost to the consumer, please note that the current mandate does not require coverage for treatment.

Accordingly, Delta Health Systems has removed the member's share of cost for the above listed services on all TCSIG plans. However, all costs related to the treatment of COVID-19 remain. (see examples below)

Example 1. - Member on HDHP goes into a provider to get tested for COVID-19. The member's deductible and coinsurance would not apply and testing include office visit and lab work would be covered at 100% no share of cost for the member.

Example 2. – Member on HDHP has received a diagnosis of COVID-19 and is admitted into the hospital for treatment. The member's deductible and coinsurance would apply and the member would have the same share of cost as they would any other illness.
