

Federal law requires Yuba Community College District to post information regarding the CARES Act, Higher Education Emergency Relief Fund (HEERF) Awards.

Each institution who received HEERF funds must comply with Section 18004(e) of the CARES Act and submit an initial report (the “30-day Fund Report”) to the Secretary thirty (30) days from the date of the institution’s Certification and Agreement to the Department and provide updates, every 45 days after that. **Each HEERF participating institution must post the information listed below on the institution’s primary website in a format and location that is easily accessible to the public.***

*This is the **final quarterly report** that covers all remaining HEERF fund expenditures for Section 18004(a)(1) Student Portion funds, after which, no further quarterly public reporting of Section 18004(a)(1) Student Portion funds are required.

The 7 required reporting elements are:

- (1) Yuba Community College District affirms that Yuba College and Woodland Community College have signed and returned to the Department of Education the Certification and Agreement of assurance that the institutions will use, or intend to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
- (2) The total amount of funds that the institution will receive or has received from the Department pursuant to the institution’s Certification and Agreement [for] Emergency Financial Aid Grants to Students.

Yuba College has received \$1,874,459.00

Woodland Community College has received \$924,649.00

- (3) The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of Fall 2020:

- (4) The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

- (5) The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

- (6) The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

Criteria for Spring 2020 Disbursement:

- Full-Time (12+ Units) with Expected Family Contribution (EFC) at or below 0 = \$500
- Full-time with EFC above 0 = \$450
- $\frac{3}{4}$ Time (9-11.9 units) with EFC at or below 0 = \$400
- $\frac{3}{4}$ Time with EFC above 0 = \$350
- Half Time (6-8.9 units) with EFC at or below 0 = \$300
- Half Time with EFC above 0 = \$250
- Less Than Half Time (LTHT) (below 6 units) and registered with Disabled Students Programs and Services (DSPS) with EFC
- at or below 0 = \$300
- LTHT DSPS with EFC above 0 = \$250

Criteria for Spring 2020 Disbursement:

- To qualify for funding, students must be enrolled in the semester for which they are requesting aid and agree to maintain enrollment.
- Students can only submit one application in a semester.

- Full-time students (12 or more units) may be eligible for up to \$500, and all other students may be eligible for up to \$300.

(7) Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.
