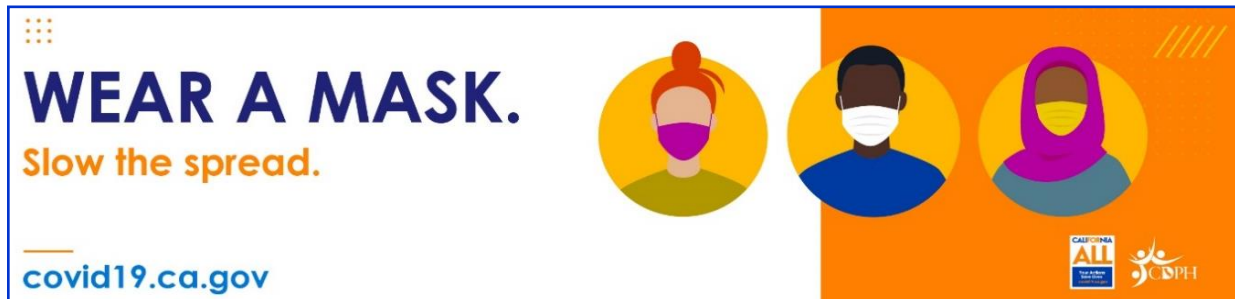

COVID-19 UPDATE

There are a total of 11,775 confirmed cases of coronavirus in the five county area served by the Yuba Community College District. That is an increase of 1,744 cases in the past week, 14.4% increase. This is the largest weekly increase in new cases since the pandemic began. Current case totals are: Colusa – 694, a 8.6 % increase; Lake – 886, a 7.7% increase; Sutter 3,332, a 26.3% increase; Yolo – 4,827 , a 15% increase with 2,010 cases in Woodland, a 14.4% increase; and Yuba – 2,036 , a 17.6% increase. For the month of November total cases have increased 51.9% in the YCCD region. Currently there are 69 patients hospitalized in our service area, 25 more than last week. Rideout Hospital that serves Yuba and Sutter Counties is at capacity with 36 patients. There have been 127 fatalities, five more than last week.

Statewide there are a total of 1,198,934 confirmed cases, an increase of 8.1% over the previous week, and a 31% increase for the month of November. Total patients currently hospitalized in the state are 7,415, a 43.4% increase and the number of ICU patients is 1,711, an increase of 33.5%. BLUEPRINT FOR A SAFER ECONOMY

[Blueprint for a Safer Economy](#) focuses on *New Daily Cases per 100,000 Population* and *Percentage of Tests that are Positive* to determine the county risk level. For each level there is specific guidance related to business and community activity that can be found in the link above. **Currently all counties in the District are in Tier 1: WIDESPREAD.** Current Positivity and New Case rates are shown on the above table. The color of the number indicates what tier that number would fall into.

Risk Level	Description	New Cases	Positive Tests
WIDESPREAD	Many non-essential indoor business operations are closed	> 7 per 100K	>8%
SUBSTANTIAL	Some non-essential indoor business operations are closed	4-7 per 100K	5-8%
MODERATE	Some indoor business operations are open w/ modifications	1-3.9 per 100K	2-4.9%
MINIMAL	Most indoor business operations are open with modifications	>1	>2%
