COVID-19 • Prevent the spread



COVID-19 STATUS IN YCCD SERVICE AREA

As of February 7, 2021 there are a total of 30,713 confirmed cases of coronavirus in the five county region served by the Yuba Community College District. That is an increase of 2.8% during the past week, and the lowest weekly increase since November 2, 2020. Total cases are shown in the chart below. Increases by county during the past week were: Colusa – 3.6%; Lake – 4.6%; Sutter – 3.0%; Yolo – 2.5%, with a 2.7% increase in Woodland; and Yuba – 2.0%. 29,040 of the confirmed cases (95.3% of the total cases count) have been classified as recovered. Currently there are 1,436 active cases in the service area. County data is from local county website dashboards. Statewide there are a total of 3,335,926 confirmed cases, an increase of 2.9% over the previous week.

Currently there are 105 patients hospitalized in our service area, which is 17 less than last week. There are 18 patients in ICU, which is six less than last week. There have been 326 fatalities, 26 more than last week.

Total patients hospitalized in the state is 11,695, a 21.3% decrease from last week, and the number of ICU patients is 3,260, a 17.3% decrease. Statewide data is from the California Department of Public Health and can be found at <https://data.chhs.ca.gov/>.

ICU capacity rates across the state are starting to show an increase. Statewide capacity is above zero for the first time in more than a month. Regional ICU capacities as of February 2 are: Northern California – 24.4%; Greater Sacramento Region – 18.4%; Bay Area – 18.1%; San Joaquin Valley – 10.7%; Southern California – 9.1%. Combined statewide capacity is 11.7%.

Blueprint for a Safer Economy focuses on *New Daily Cases per 100,000 Population* and *Percentage of Tests that are Positive* to determine a county's risk level. For each level there is specific guidance related to business and community activity. That information can be found in the link above. **Currently all counties in the YCCD District are in Tier 1, the most restrictive Tier.** Current Positivity and New Case rates are shown on the above table. The color of the number indicates what tier that number would fall into.

COVID VACCINE UPDATE

As of February 7, a total of 49,733 doses of COVID Vaccine have been administered in our five county region. Statewide a total of 4,650,637 doses have been administered. This represents 66.8% of the doses that are currently available in the state.

I am already hearing from a few of our colleagues over 65 that they have received their first shots through diligently checking their county websites and scheduling appointments.
