### Trustee Areas Description

**Trustee Area 1:** The region bounded and described as follows: Beginning at the intersection of Griffith Avenue and Hammonton Smartsville Road running southwest along the centerline of Hammonton Smartsville Road to its intersection with Simpson Lane; then continuing southwest along the southern edge of parcel 018-230-045 and continuing west along the southern edge of parcels 018-230-038, 018-230-027, 020-030-0045 and 020-030-046; then northwest and north along the western edge of parcels 020-030-044, 020-030-001, 018-230-031, 018-230-029, 018-230-019, 018-230-018, and 018-230-044 to its intersection with Levee Road; then northeast along the centerline of Levee Road to its intersection with East 17<sup>th</sup> Street; then west along the centerline of East 17<sup>th</sup> Street to its intersection with Hall Street; then north along the centerline of Hall Street to its intersection with Johnson Avenue; then west along the centerline of Johnson Avenue to its intersection with Huston Street; then north along the centerline and logical extension of Huston Street to its intersection with boundary of the City of Yuba; then west along the northern boundary of the City of Yuba to its intersection with the Feather River; then north along the Feather River to its intersection with the exterior boundary of Yuba Community College District (YCCD); then generally northeast and south and west along the exterior boundary of YCCD to its intersection with the Sacramento River/Feather River; then generally north along the Sacramento/Feather River to its intersection with parcel 029-230-010; then north along the eastern edge of parcel 029-230-010 and 029-230-011 to its intersection with the Sutter Bypass; then generally north along the Sutter Bypass to its intersection with Hughes Road; then east along the centerline of Hughes Road to its intersection with Schlag Road; then south along the centerline of Schlag Road to its intersection with Oswald Road; then east along the centerline of Oswald Road to its intersection with South George Washington Boulevard; then north along the centerline of South George Washington Boulevard to its intersection with Bogue Road; then east along the centerline of Bogue Road to its intersection with Sanborn Road; then north along the centerline of Sanborn Road to its intersection with La Rabyn Way; then east along the centerline of La Rabyn Way to its intersection with Jodi Drive; then north along the centerline of Jodi Drive to its intersection with Sofia Drive; then east along the centerline of Sofia Drive to its intersection with Yolanda Drive; then south along the centerline of Yolanda Drive and continuing east and north along the centerline of Johnathan Drive to its intersection with Tracy Drive; then east along the centerline of Tracy Drive to its intersection with South Walton Avenue; then south along the centerline of South Walton Avenue to its intersection with Smith Road; then east along the centerline of Smith Road to its intersection with the southwest corner of parcel 022-060-028; then north and east and south along the edge of parcel 022-060-028 to its intersection with Smith Road; then east along the centerline of Smith Road to its intersection with Highway 99; then south along the centerline of Highway 99 to its intersection with Railroad Avenue; then east along the centerline of Railroad Avenue to its intersection with the boundary of the City of Yuba; then generally south along the boundary of the City of Yuba to its intersection with Garden Highway; then south along the centerline of Garden Highway to its intersection with Boyd Pump Road; then east along Boy Pump Road and continuing south along the centerline of Levee Road to its intersection with the northern edge of parcel 023-234-015; then east along the northern edge of parcel 023-234-015 and its

logical extension to its intersection with the Yuba River; then northeast along the Yuba River to its intersection with Ella Avenue; then east along the centerline of Ella Avenue to its intersection with Arboga Road; then south along the centerline of Arboga Road to its intersection with Plumas Arboga Road; then east along the centerline of Plumas Arboga Road to its intersection with the northwest corner of parcel 014-350-031; then southeast along the western edge of parcel 014-350-031 and continuing southeast along parcel lines to parcel 014-530-013 to its intersection with Highway 70; then north along the centerline of Highway 70 to its intersection with the boundary of the City of Olivehurst; then northeast along the boundary of the City of Olivehurst to its intersection with Rancho Road; then northwest along the centerline of Rancho Road to its intersection with McGowan Parkway; then west along the centerline of McGowan Parkway to its intersection with Highway 65; then northwest along the centerline of Highway 65 and continuing northwest along the boundary of the City of Olivehurst to its intersection with the boundary of the City of Linda; then east and north along the boundary of the City of Linda to its intersection with Hammonton Smartsville Road; then southwest along the centerline of Hammonton Smartsville Road to the point of Origin.

**Trustee Area 2:** The region bounded and described as follows: Beginning at the intersection of Griffith Avenue and Hammonton Smartsville Road running southwest along the centerline of Hammonton Smartsville Road to its intersection with Simpson Lane; then continuing southwest along the southern edge of parcel 018-230-045 and continuing west along the southern edge of parcels 018-230-038, 018-230-027, 020-030-0045 and 020-030-046; then northwest and north along the western edge of parcels 020-030-044, 020-030-001, 018-230-031, 018-230-029, 018-230-019, 018-230-018, and 018-230-044 to its intersection with Levee Road; then northeast along the centerline of Levee Road to its intersection with East 17<sup>th</sup> Street; then west along the centerline of East 17<sup>th</sup> Street to its intersection with Hall Street; then north along the centerline of Hall Street to its intersection with Johnson Avenue; then west along the centerline of Johnson Avenue to its intersection with Huston Street; then north along the centerline and logical extension of Huston Street to its intersection with boundary of the City of Yuba; then west along the northern boundary of the City of Yuba to its intersection with the Feather River; then south along the Feather River to its intersection with Ella Avenue; then east along the centerline of Ella Avenue to its intersection with Arboga Road; then south along the centerline of Arboga Road to its intersection with Plumas Arboga Road; then east along the centerline of Plumas Arboga Road to its intersection with the northwest corner of parcel 014-350-031; then southeast along the western edge of parcel 014-350-031 and continuing southeast along parcel lines to parcel 014-530-013 to its intersection with Highway 70; then north along the centerline of Highway 70 to its intersection with the boundary of the City of Olivehurst; then northeast along the boundary of the City of Olivehurst to its intersection with Rancho Road; then northwest along the centerline of Rancho Road to its intersection with McGowan Parkway; then west along the centerline of McGowan Parkway to its intersection with Highway 65; then northwest along the centerline of Highway 65 and continuing northwest along the boundary of the City of Olivehurst to its intersection with the boundary of the City of Linda; then east and north along the boundary of the City of Linda to its intersection with Hammonton Smartsville Road; then southwest along the centerline of Hammonton Smartsville Road to the point of Origin.

**Trustee Area 3:** The region bounded and described as follows: Beginning at the intersection of Schlag Avenue and Oswald Road running east along the centerline of Oswald Road to its intersection with South George Washington Boulevard; then north along the centerline of South George Washington Boulevard to its intersection with Bogue Road; then east along the centerline of Bogue Road to its intersection with Sanborn Road; then north along the centerline of Sanborn Road to its intersection with La Rabyn Way; then east along the centerline of La Rabyn Way to its intersection with Jodi Drive; then north along the centerline of Jodi Drive to its intersection with Sofia Drive; then east along the centerline of Sofia Drive to its intersection with Yolanda Drive; then south along the centerline of Yolanda Drive and continuing east and north along the centerline of Johnathan Drive to its intersection with Tracy Drive; then east along the centerline of Tracy Drive to its intersection with South Walton Avenue; then south along the centerline of South Walton Avenue to its intersection with Smith Road; then east along the centerline of Smith Road to its intersection with the southwest corner of parcel 022-060-028; then north and east and south along the edge of parcel 022-060-028 to its intersection with Smith Road; then east along the centerline of Smith Road to its intersection with Highway 99; then south along the centerline of Highway 99 to its intersection with Railroad Avenue; then northeast and north along the centerline of Railroad Avenue to its intersection with Lincoln Road; then west along the centerline of Lincoln Road to its intersection with Highway 99; then north along the centerline of Highway 99 to its intersection with the logical extension of the southwest corner of parcel 020-080-006; then north along the eastern edge of parcel 020-080-006 and continuing northeast along parcel lines from parcel 020-0243-004 through 053-050-008 to its intersection with parcel 026-102-012; then north along the eastern edge of parcel 026-102-012 and continuing north along parcel lines to its intersection with the southern edge of parcel 053-140-033; then west along the southern edge of parcel 053-140-033 and continuing west along parcel lines to its intersection with South Barrett Road; then north along the centerline of South Barrett Road to its intersection with Franklin Avenue; then west along the centerline of Franklin Avenue to its intersection with Highway 99; then north along the centerline of Highway 99 to its intersection with Butte House Road; then northwest along the centerline of Butte House Road to its intersection with Blevin Road; then north along the centerline of Blevin Road to its intersection with the boundary of the City of Yuba; then generally east along the boundary of the City of Yuba to its intersection with the Feather River; then north along the Feather River to its intersection with the Exterior Boundary of YCCD; then west along the exterior boundary of YCCD to its intersection with Butte Creek; then south along Butte Creek to its intersection with Butte Slough; then south along Butte Slough to its intersection with Pass Road; then continuing south along the western edge of parcel 013-070-083 and then west along the southern edge of parcels 013-070-083, 013-070-084, 013-070-069 and 013-070-096 to its intersection with West Butte Road; then southeast along the edge of Census Blocks 061010508001044, 061010508001045, 061010508001058, 061010508001057, 061010508001056, 061010508001060, 061010508001071, and 061010508001075 to its intersection with Sutter Bypass; then south along the Sutter Bypass to its intersection with Hughes Road; then east along the centerline of Hughes Road to its intersection with Schlag Road; then south along the centerline of Schlag Road to the point of origin.

**Trustee Area 4:** The region bounded and described as follows: Beginning at the intersection of Bogue Road and Railroad Avenue running northeast and north along the centerline of Railroad Avenue to its intersection with Lincoln Road; then west along the centerline of Lincoln Road to its intersection with Highway 99; then north along the centerline of Highway 99 to its intersection with the logical extension of the southwest corner of parcel 020-080-006; then north along the eastern edge of parcel 020-080-006 and continuing northeast along parcel lines from parcel 020-0243-004 through 053-050-008 to its intersection with parcel 026-102-012; then north along the eastern edge of parcel 026-102-012 and continuing north along parcel lines to its intersection with the southern edge of parcel 053-140-033; then west along the southern edge of parcel 053-140-033 and continuing west along parcel lines to its intersection with South Barrett Road; then north along the centerline of South Barrett Road to its intersection with Franklin Avenue; then west along the centerline of Franklin Avenue to its intersection with Highway 99; then north along the centerline of Highway 99 to its intersection with Butte House Road; then northwest along the centerline of Butte House Road to its intersection with Blevin Road; then north along the centerline of Blevin Road to its intersection with the boundary of the City of Yuba; then generally east along the boundary of the City of Yuba to its intersection with the Feather River; then south along the Feather River and Yuba River to its intersection with the northern edge of parcel 023-234-015; then west along the northern edge of parcel 023-234-015 to its intersection with Levee Road; then north along Levee Road and continuing west along Boyd Pump Road to its intersection with Garden Highway; then northeast and north along the centerline of Garden Highway to its intersection with the boundary of the City of Yuba; then generally north and west along the boundary of the City of Yuba to its intersection with Bogue Road; then southwest along the centerline of Bogue Road to the point of origin.

**Trustee Area 5:** The region bounded and described as follows: Beginning at the intersection of Yolo County Road 27 and Yolo County Road 95 running north along the centerline of County Road 95 to its intersection with Highway 16; the east along the centerline to Highway 16 to its intersection with Interstate 5; then southeast and east along the centerline of Interstate 5 to its intersection with the exterior boundary of YCCD; then south and east along the exterior boundary of YCCD to its intersection with Yolo County Road 95; then north along the centerline of Yolo County Road 95 to the point of origin.

**Trustee Area 6:** The region bounded and described as follows: Beginning at the intersection of Highway 20 and East Camp Road running east along the centerline of Highway 20 to its intersection with Census Block 060110002005039; then southeast along the edge of Census Blocks 060110002005039, 060110002005029, 060110002000028, 060110002005031, 060110002005028, 060110002005027, 060110002005026, 060110002005008, 060110002005007, 060110002005019, 060110002005001, 060110002005000, 061010509001004, 061010509001002, 061010509001008, and 061010509001009 to its intersection with the southwest corner of parcel 013-070-083; then west along the southern edge of parcels 013-070-083, 013-070-084, 013-070-069 and 013-070-096 to its intersection with West Butte Road; then southeast along the edge of Census Blocks 061010508001044, 061010508001045, 061010508001058, 061010508001057, 061010508001056, 061010508001060, 061010508001071, and 061010508001075 to its intersection with Sutter

Bypass; then south along the Sutter Bypass to its intersection with parcel 029-230-011; then south along the eastern edge of parcels 029-230-011 and 029-230-010 to its intersection with the Sacramento/Feather River; then south along the Sacramento/Feather River and the exterior boundary of YCCD to its intersection with Interstate 5; then west along the centerline of Interstate 5 to its intersection with Highway 16; then west along the centerline of Highway 16 to its intersection with Yolo County Road 95; then south along the centerline of Yolo County Road 95 to its intersection with the exterior boundary of YCCD; then generally west along the exterior boundary of YCCD to its intersection with the boundary of Lake County; then north and east along the Lake County/Yolo County boundary to its intersection with Census Block 060110003021202; then north along the western edge of Census Blocks 060110003021202, 060110003021201, 060110003021186, and 060110003021124; then west along the northern edge of Census Blocks 060110003021124 and 060110003021123 to its intersection with Census Block 060110003021120; then north along the edge of Census Block 060110003021120 to its intersection with Census Block 060110003021109; then east and northwest along the edge of Census Block 060110003021109 to its intersection with East Camp Road; then north along the centerline of East Camp Road to the point of origin.
