16    16.1    Unit members have the right to apply for any full-time faculty vacancy.

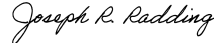

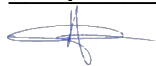
21    **16.3.    At the request of YC-AFT, the parties shall meet and discuss as part of a labor-**
