Proportionality Test

The Proportionality Test, often referred to as the "Three-Part Test," is one of the primary standards used to evaluate gender equity in athletic programs. According to this test, an institution is compliant with Title IX if the number of male and female athletes is substantially proportional to the number of male and female students. If the numbers do not align, institutions must take measures to rectify the imbalance.

History and Continuing Practice Test

Another important aspect of Title IX is the consideration of past and ongoing practices. This test examines whether an institution has a history of expanding and developing athletic opportunities for the underrepresented gender. If an institution can demonstrate a history and a continued effort to provide opportunities to the underrepresented gender, it may be in compliance with Title IX, even if the Proportionality Test is not met.

Full and Effective Accommodation Test

This test evaluates whether the institution is fully accommodating the interests and abilities of both genders in athletics. This means ensuring that male and female athletes receive equal access to resources, including coaching, scholarships, equipment, facilities, and scheduling. It is essential that no gender faces discrimination or disadvantage in their athletic pursuits.

Separate, But Unequal Facilities and Services Test

Title IX also prohibits educational institutions from providing separate but unequal facilities or services to male and female athletes. This test examines whether the quality and availability of facilities and services are equivalent for both genders. If disparities exist, they must be addressed to ensure equality.

Equal Treatment of Male and Female Student-Athletes

One of the fundamental principles of Title IX is ensuring that male and female student-athletes are treated equally in all aspects of their participation. This includes not only the opportunity to play but also coaching, equipment, travel opportunities, and funding.
